



With smart goals to develop a system for conscious, consistent and catalytic action to improve the academic and administrative performance of the institution, to keep the institution abreast of the abuzz with quality sustenance activities on a wide gamut of pertinent issues, and to generate good practices, ideas, planning, implementing and measuring the outcome of academic and administrative performance of the institution, the Internal Quality Assurance Cell of Madurai Kamaraj University was established in the year 2005.

Madurai Kamaraj University is marching towards the Golden Jubilee celebrations with great establishments and records. Internal Quality Assurance Cell (IQAC) has been made as an integral and independent part of this university by the present Vice Chancellor. 
Functions:

The documentation of the various activities of the Madurai Kamaraj University has been performed by the IQAC for quality improvement. The IQAC also acts as a Nodal Agency for the University co-ordinating the Quality related activities including adoption and dissemination of good practices. The IQAC has developed the data base for the Madurai Kamaraj University for the purpose of maintaining and enhancing the institutional quality.

Activities:

Meetings were convened at regular intervals to discuss the introduction of new and innovative courses, interaction between the schools, modalities for implementing more Co-curricular activities for students and to promote faculty competency and ensure development programmes.

Annual Self-assessment of Faculty members in the University Departments for performance based appraisal system (PBAS) was collected for the year 2013-14. Students feed back for the academic year 2013-14 was also collected and valuable suggestions were made by the IQAC. A vital aspect of the feedback is shown below:



The Annual Quality Assurance Report (AQAR) 2013-2014 will be submitted shortly.

The Academic Audit was conducted for all the Schools of the University during July and August, 2014. The Review of the Academic Audit Reports is in progress and it is proposed to

provide appropriate recommendations to the University administration and to the individual schools for quality improvement.

The IQAC has conducted a one day Workshop on "Learner-Centered Teaching: Theory and Practice" on 9th September, with United States-India Educational Foundation (USIEF).

The IQAC has also facilitated the Reform of CBCS Regulations and structure and a CBCS Hand Book was released on 5th September, 2014.

Achievements:



The IQAC has facilitated the NAAC Peer Team visit for the re-accreditation 3rd Cycle from 5th May 2014 to 9th May 2014.

The University successfully completed the NAAC Re-accreditation 3rd Cycle and got Re-accredited with 'A' grade.
