Tender in sealed covers superscribed as Tender for work for conducting on-line entrance test for admission to M.Phil and Ph.D programmes for Research Section, Madurai Kamaraj University Addressed to The Registrar-in-charge, Madurai Kamaraj University, Madurai - 625 021. The University will not be held responsible for the postal delay and postal transit.

The tenderer should enclose an attested xerox copy of the commercial tax certificate regarding GST number. The work should be made within 30 days from the date of receipt of supply order.

The list of clients where the similar nature of works executed by the tenderer shall be provided. Filing of last three years income tax return shall be provided. The Gross annual turnover in similar works shall also be provided.

The rates quoted by the firm should be valid for a period of one year from the date of acceptance of tender and no escalation of rates will be allowed under any circumstance. A crossed demand draft 1% to the total cost value should be drawn in favour of the Registrar, Madurai Kamaraj University, Madurai towards Earnest Money Deposit should accompany the Tender.
