- 2 (i). - 2 (ii). The scheme of examinations, conduct of internal and external examinations, credits calculation, assessment method, question paper pattern and model question paper followed for the existing Part –III subjects be applicable for the new Professional English Book also, however the credits/marks obtained by him/her shall not be included in the Cumulative Grade Point Average (CGPA) and for classification.
