 - The experts shall not be listed not more than one from the same University / Institution. Do not submit the photocopies of the examiner's panel proposed by other faculty members or by you for your other research scholars.
 - The expert panel (preferably at the level of Associate Professor / Professor) shall be provided with the present position, postal address, email, contact number, and with **official weblink** of the experts as per the following format, mentioning the title of the Ph.D. Thesis on the top.


