INSTRUCTIONS

It is informed that the following guidelines should be adhered to while seeking verification of the certificates issued by this University.

- With effect from 01.04.2018, a sum of Rs.1800/- (fee for request made from the organizations in India) or US \$90 (including Postal Charge) (in the case of request from a foreign country) should be remitted to the University "ONLY THROUGH SBI ONLINE PAYMENT" towards verification and issue of Genuineness Certificate (for each course / certificate). The Payment other than online could not be accepted.
- 2. The agency/organization, which sends the request, is requested to send the clear Photo copy (full image including the signature) of the Consolidated Statement of Marks or Provisional Certificate or Convocation Degree Certificate whichever is applicable.
- 3. The applications should be sent to "The Controller of Examinations, Madurai Kamaraj University, Palkalai Nagar, Madurai 625 021", which is applicable to all the candidates (including DDE) applying for Genuineness for Degree Certificate as well as the candidates studied in regular mode applying Genuineness for Semester Mark Statements / Consolidated Mark Statement / Provisional Certificate.
- 4. The applications of the **DDE candidates**, except Genuineness for Degree Certificate, should be sent to the "Additional Controller of Examinations, Directorate of Distance Education, Madurai Kamaraj University, Madurai 625 021"
- 5. The Employer /Verification Agency can only apply for Genuineness Certificates for the candidates.
- 6. The Genuineness Certificate could not be processed without this application form at any circumstances.
- 7. The Genuineness Certificate will not be given to the candidate in person at any circumstances.
- 8. The Candidates should not come in person to inquire about their genuineness certificates failing which the Genuineness application form will be treated as invalid since it is a confidential report.
- 9. This application will be rejected without the signature of the Employer / Verification Agency with seal and address.
