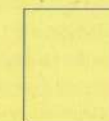

The responsibility for all aspects of paper preparation rests with the authors. Extensive changes or rewriting of the accepted paper will not be undertaken by the selection committee for publication. The first page must contain the title of the paper and name of the author, designation, affiliation, contact number and E-mail ID. The manuscript will be subjected to blind review process. Decision of the reviewer will be final. All selected papers will be published in proceedings will ISBN/ISSN.

Presenters will have 15 minutes for presentation after which the chair will give the comment for 10 minutes followed by an open discussion for 10 minutes. Delegates are requested to forward the papers to the seminar.
